Meeting Summary

Russian River Water Forum Working Group: Water Rights & Water Management Meeting #4 (Parts 1 and 2)

Zoom

Monday, October 16, 2023, 12:00 pm to 1:00 pm Wednesday, October 18, 2023, 1:00 pm to 3:00 pm

Summary

The Russian River Water Forum held the fourth meeting of the Water Rights & Water Management Working Group via Zoom on October 16. The meeting was facilitated by Kearns & West. Presentation slides and a recording of the meeting are available on the project website. To allow for continued discussion, a second session was held on October 18.

The meeting objectives were as follows:

- Review the draft work product and receive feedback
- Discuss next steps

The meeting agenda and a list of attendees are in Appendices A and B. The Oct 16 meeting had 24 attendees and the Oct 18 meeting had 19 attendees.

The next section provides a summary of the takeaways and action items from the meetings.

Action Items – October 16 meeting

- **Glen Spain, PCFFA,** to share information on canneries or other commercial fishing-related information for the Eel and Russian rivers circa 1900.
- Laurel Marcus, California Land Stewardship Institute, to share information on pre-PVP conditions in the Upper Russian River, and on studies regarding hydrologic connectivity between the Russian River channel and aquifers in the region (Ukiah Valley and Alexander Valley studies)
- **Todd Schram, Sonoma Water,** to follow up regarding the Upper Russian River "Riparian" and "Uncategorized" water demand categories.
- Beth Salomone, RRFC, to follow up regarding water demand information presented on Redwood Valley CWD.

Action Items - October 18 meeting

• **Don Seymour, Sonoma Water,** to follow up regarding availability of water demand data for the Lower Russian River.

Takeaways – October 16 meeting

- David Taber presented a selection of key slides from the draft Work Product. Working Group participants provided input:
 - Slide title: Before the Dams
 - Include information on water demand in 1900, if available.
 - Include information on canneries and/or commercial fisheries supported by the rivers in 1900.
 - The Working Group discussed what is known about how frequently the Upper Russian River ceased to flow during the dry season prior to the trans-basin diversion. Members discussed whether it should be characterized as discontinuous pools, going dry, or going underground. The science review panel report may be a source of information on this issue.
 - Clarify the meaning on the number of people served by the rivers circa 1900.
 - o Slide title: Regulatory Required Flows Slide
 - Clarify that this slide refers to both Eel and Russian rivers.
 - Note that there are multiple federal mandates in place, including the Wild and Scenic River designation and the Biological Opinions.
 - Clarify that the Biological Opinion is being updated.
 - o Slide title: Tribal Water Rights
 - Clarify that the Federal Reserved Rights are tied to the establishment of a reservation, rather than to the federal recognition of a Tribe.
 - Slide title: Categories of Water Rights
 - Regarding the "R" in the table, clarify that it is a storage reserve for Sonoma County water users.
 - For the 10,000 acre-foot reservation, use "reserve" rather than "reservation"
 - Spell out the R and WC in the table (rather than in a footnote)
 - Consider including a row for pre-1914 rights.
 - Consider including a row for pre-1905 rights
 - Reiterate that there are regulatory constraints on flows. That are separate from these state water rights.
 - Slide: Two Scenarios
 - Use the term "Trans-basin diversion" rather than "interbasin transfer."
 - Slide: Projected impacts on Lake Mendocino Water Supply
 - Use consistent terms in this slide (consistent throughout presentation)
 - Regarding impacts to aquifers if the Upper Russian River bed runs dry, the drafting team should review the Ukiah Valley Groundwater Sustainability Plan and the USGS study of Alexander Valley.
 - The issue of potential impacts to aquifers should be its own bullet rather than a footnote.
 - Clarify the assumptions about water management in the models: A key assumption is that there is no change in management, there should be a note about that.

- Clarify that curtailments referenced here are surface water curtailments (rather than groundwater curtailments).
- Expand the sub-bullets for clarity.
- Slides: Effects on Upper Russian River Water Rights
 - Clarify what the "riparian" category refers to. Is it riparian vegetation demands, or water diversions by riparian rights holders?
 - The Redwood Valley CWD water demand figure appears to be Mike H.: Need to research.
 - When speaking of water rights, clarify that they are state water rights (as opposed to Tribal reserved rights or federal reserved rights)
 - In the no-transbasin diversion scenarios, need more clarity on the when the curtailments were in effect (or just say "in the most recent drought" rather than presenting years).

Takeaways – October 18 meeting

- David Taber presented a selection of key slides from the draft Work Product. Working Group participants provided input:
 - The group discussed terminology for water imported via the Potter Valley Project. The group agreed on "Interbasin water imports."
 - o Slide: Upper Russian River Demand
 - It was clarified that the "Riparian" category refers to evapotranspiration demand from riparian vegetation, rather than diversion by riparian water rights holders.
 - It was clarified that the data shown reflect figures from 2019 (rather than averages over multiple years).
 - It was clarified that the Cloverdale reach extends to the Mendocino-Sonoma county line.
 - It was noted that Redwood Valley demand is less than shown.
 - o Slide: Lower Russian River Demand
 - Action item: Don Seymour to follow up on availability of water demand data.
 - Slide: Eel River Water Demand
 - Sam Bolan-Brien clarified that SWRCB is preparing data on water use by water right for the Eel River; the figures won't be divided by use category.
 - Slide: Regulatorily required flows limit water availability
 - The group revised the wording of the third bullet.
 - Slide: Tribal Reserved Water Rights
 - The group revised the text, and added a citation to the Winters decision.
 - Slide: Interbasin Imports
 - Suggestion: on the "Past Transbasin Transfers" chart, label what the three periods shown represent (i.e., what changed)...
 - Slide: Impacts of climate change on water supply
 - Spell out all acronyms

- Slide: The past is not the future
 - Delete the note on illegal transfers
- Slide: Impacts on Lake Mendocino
 - The Two-Basin Solution modeling findings were clarified.
 - Regarding impacts on local groundwater -- SW and USGS are developing a model (results not yet available).
- o Slide: Scenario 2 effect on Upper Russian River State Water Rights
 - Consider more specific language for "occasional summertime water shortage"
- Slide: Scenario 3 effect:
 - Clarify the definition of curtailment
- Slide: Conclusions
 - In severe drought: curtailment may happen on the Russian Rier
 - SWRCB has ability to curtail use of water; water right holders can also bring trespass actions.
 - Riparian rights clarify that this refers to for both rivers
 - Impacts on riparians are that, practically speaking, there is more scrutiny during dry years.
- General comments:
 - Be clear about what is known v. what is speculative
 - When presenting the impact of continuing water imports, suggest positive framing: Imports continuing will reduce the magnitude and frequency of water shortages.
