

Outcomes and Follow-up from May 17 Planning Group Kick-off Meeting



Meeting 1 Outcomes

- Achieved meeting objectives
- Broad support for PG charter w/ some clarifications
- PG members identified interests and hopes for PVP decommissioning process
- Discussed tension b/n achieving common understanding and identifying path forward quickly
- Group agreed (by consensus) to add Lake Pillsbury Alliance to PG
- Significant interest in convening RR Resilience Subcommittee sooner than proposed



Revisions to Planning Group Charter

- Planning Group description (p5): addition of Steering Committee to help reach consensus
- External Communications (p7):
 - Added: Members may share progress updates and publicly available documents from Planning Group meetings.
 - Removed: requirement to consult Planning Group before outreach to state and federal policy contacts.
 - Added: if asked to speak on behalf of the Planning Group or provide a briefing, consult Facilitation Team and Steering Committee.

Planning Group Decision-Making

- Concerns from PG members re: including voting in decisionmaking
- Facilitation team proposal:
 - Strive for consensus across group, i.e. "can live with"
 - If not, provide explanation and alternative solution
 - Steering Committee is a resource to identify path forward
 - Revisit approach after PG Meeting #4 (August)
- Important to work from interests when striving for consensus
- Consensus/agreement not always required to move forward, document areas of convergence and divergence

WATER FORUM

Summary of Planning Group member interests

- Review synthesis of interests, confirm we have all key interests identified.
- Revisit group's commitment to satisfying multiple interests.



PG&E Decommissioning Schedule and Planning Group Process



- In response to a requested action from May 17 kick-off meeting, K&W sought clarifying statements from PG&E regarding statements shared during that meeting and in other public forums.
- Statements in black on slides that follow are K&W's representations of these statements.
- Statements in green on the coming slides are PG&E's clarifications, shared verbatim; PG&E's interest is that everyone has the same information regarding the decommissioning process.
- Kearns & West cannot speak for PG&E.



- PG&E's decommissioning plan will include full facilities removal.
- Clarification: PG&E's decommissioning plan will include the removal of in water facilities such that no feature will continue to impound water and the natural flow of the river will occur.



- PG&E opened the door to additional conversation, but applications will only be considered if interests are met from both basins. One of PG&E's requirements is that both dams are removed.
- Clarification: PG&E is open to proposals for project facilities. Our hope is that there is buy in by multiple stakeholders.



- PG&E is considering expedited partial or full removal of Scott Dam as a long-term mitigation measure.
- Clarification: PG&E is continuing to evaluate Scott Dam and will mitigate any dam safety concerns as appropriate.



- PG&E plans to remove Scott Dam as soon as 2028.
- Clarification: PG&E's final draft surrender application and decommissioning plan is due to FERC in January 2025. Once we have filed with FERC there will be an environmental review. There is no regulatory timeline for FERC to issue an order for the decommissioning. PG&E is hopeful that an order will be issued in 2028.



- The cost of Scott Dam removal would be \$30 million.
- Clarification: At this time PG&E does not have the cost of removal of Scott Dam.



- PG&E will be allowed to recover the cost of dam removal from ratepayers.
- Clarification: PG&E proposed and the CPUC approved a
 Decommissioning fund in the 2020 General Rate Case
 Proceeding. The Decommissioning funds will be used to
 remove the dams. PG&E determined that it was less costly
 for our ratepayers to remove the dams than continue to own
 and operate the facilities.
